


Happy Summer!

#### NAPLES AIRPORT - UPDATE

#### VACANT LOT MAINTENANCE

As we enter rainy season, please be reminded of the City's Code for Vacant Lot Maintenance, which states that all vacant lots shall be covered with sod, ground cover or other cultivated landscape materials unless there is an active building permit on the property and the appropriate construction fencing is in place. All grasses or weeds, and uncultivated vegetation, shall not exceed 8 inches in height. For more information on the City Code, please refer to Sec. 16-284.



## LIGHTS OUT! SEA TURTLE NESTING SEASON IS UPON US (May through October)

The City of Naples is asking for assistance in protecting sea turtles and their critical nesting environment throughout the duration of nesting season by limiting nighttime beach activities, keeping the beaches dark, and staying away from nesting females or hatchlings if you see them. *Read More Here*

#### STREET LIGHT OUT? REPORT IT VIA FPL

If you notice an FPL streetlight is out near your home or within the Port Royal community, please report the outage on FPL.com. If possible, take a photo of the pole number (located on the pole) to help the team better identify the pole. The Association is still working with FPL to restore the lights that were damaged in Hurricane Ian, but if you notice an outage, you can help our community and report it *HERE*.



#### NAPLES PIER - REBUILD INFORMATION

The Naples Pier, which was destroyed by Hurricane Ian, will be built stronger and taller, with new features including more shaded areas and seating to take in the Gulf views. 
## TRASH BINS AND COLLECTION: KNOW THE CODES OR RISK A FINE

# Summer Health & Safety Updates

## DOH-COLLIER ISSUES WATER QUALITY HEALTH ADVISORY IN CITY OF NAPLES | JULY 11, 2024



The Florida Department of Health in Collier County (DOH-Collier) has issued water quality advisories for the following locations: Naples Pier, Lowdermilk Beach, and Doctors Pass in Naples, FL.

Tests completed on Thursday, July 11, 2024, indicate that the water quality at these locations do not meet the recreational water quality criteria for Enterococcus bacteria recommended by the Florida Department of Health. DOH-Collier advises against any water-related activities at this location due to an increased risk of illness in swimmers. Sampling conducted during regular water quality monitoring showed that the level of bacteria exceeds the level established by state guidelines. This advisory will continue until bacteria levels are below the accepted health level.

#### PYTHON HATCHLING SEASON- BE VIGILANT!

Burmese pythons are non-native snakes with an expanding population throughout southern Florida. In the past several months, pythons have been documented dispersing into Port Royal via the waterways looking for dry places to nest. Though they are not a direct threat to people, it is important that these invasive snakes are removed immediately from the community. Management of the issue in this area relies on a large network of individuals reporting python sightings real time - this includes communicating with your landscape contractors who are tending to the vegetation on a regular basis.

The Conservancy of Southwest Florida has been involved in research and removal efforts for the Burmese Python since 2013. To date they have removed over 1,200 pythons weighing over 36,000 pounds from western Collier County. If you or someone on your property sees a python in Port Royal (or in Naples), immediately call the Conservancy of Southwest Florida and report the sighting, and if possible, keep eyes on the snake until their staff arrive.
