WATERFRONT PLANTINGS: PORT ROYAL

As a reminder, plantings along the waterfront, or beyond the rear building setback line, should be installed and maintained at 48 inches, or in line with the pool fence. This provision is set forth by the Port Royal® Property Owners' Association <u>Deed Restrictions</u>, which run with each property, and state that waterfront plantings may not obstruct the view corridors of the neighboring properties. This particular Deed was established to protect waterward views, promote the enjoyment of living in a waterfront community, and maintain property values. We encourage you to first communicate with your neighbor if there are concerns about hedge heights and view corridors.



COMMERCIAL VEHICLE PARKING

All commercial vehicles must park within the confines of your property. This includes construction and landscape vehicles, pool and HVAC service vehicles, and more. Violators of this City Ordinance will be ticketed by the Naples Police.



CITY COUNCIL APPROVES TAX INCREASE

City Council tentatively approved a slight tax increase, which equates to \$12 more a year for a \$600,000 home. The general fund millage rate is increasing from 1.17 mil, up from 1.15 mils. This increase is to meet operational costs and to maintain sufficient revenues - estimated at \$4.8 million in additional revenues.





ONGOING HURRICANE IAN RESTORATION



Throughout the summer, the Beautification Committee has been diligently working on the restoration of our community post-Ian, from enhancing the four "main entrances", which are maintained by the Association, to facilitating with the City of Naples on replanting all common areas, throughout Port Royal.

The Committee has had many meetings with City of Naples staff over the summer to provide direction and input on all common area restoration and design. The Committee has identified specific plant material to be installed in Port Royal that promote longevity and minimal upkeep, while providing a clean and

manicured aesthetic that properly suits our beautiful community.

While the restoration process has taken longer than we would have liked, it is clear that the city staff has much work to be done across the city. There are still several beach accesses that were critically damaged in Ian and require proper engineering in order for them to safely reopen. Removal of dead vegetation and replanting has begun, albeit slowly, and the repair of the broken electrical equipment boxes such as Comcast and CenturyLink are being tended to. The beautification committee will continue to work expeditiously to remedy these problem areas with the support of City staff. Thank you for your patience and understanding as we continue to navigate these unique times.







FPL UNDERGROUND CONVERSION PROJECT ADVANCES TO CITY COUNCIL





On September 7th, the Association petitioned the City Council for their assistance in advancing the underground conversion of FPL's overhead power lines throughout our community. Over the summer months, the newly formed Utilities Committee, led by Board members Michael Lenhard and Joseph Blomker, conducted a thorough inventory of all FPL poles and wires in Port Royal during in the excessive heat this summer, and provided this data to the City of Naples and FPL for review. The Council voted 5-2 (in favor: Blankenship, Christman, Hutchison, Perry, Petrunoff; against: Heitmann, McCabe) in favor of directing city staff to research and determine costs associated with a consultant to oversee this project. Once costs are identified, the City Council will reconvene and ensure that resources can be allocated to advancing this project forward.

FAA, as they consider changes to mitigate noise generated by Naples Airport. We are concerned that the NAA has taken this approach, as they have seemingly been supportive of our efforts, and that of our coalition of SIX Homeowners' Association groups. We will continue to monitor how this moves through the various divisions and again express our opposition of and dismay over such a dispersion proposal, which simply reallocates noise.

SENATE BILL 250, LAND USE AND ZONING REGULATIONS

During the City Council Meeting on August 16th, the Council reviewed and discussed the implementation of Senate Bill 250, which states that cities or counties, either entirely or partially located within 100 miles of Hurricane Ian or Nicole's landfall, shall not propose or adopt more restrictive or burdensome amendments to the comprehensive plan or land development regulations. The law reads that more burdensome or restrictive regulations enacted after Hurricane Ian made landfall would be null and void.

The Council voted 4-3 to approve a motion by Vice Mayor Mike McCabe that would maintain all zoning and land use ordinances drafted by the City of Naples post-Ian, but temporarily suspend enforcement of them and ask the state for, or file suit, to explain Senate Bill 250 in its entirety and the intent for which it was done. Councilmen Christman, Perry, and Blankenship voted against this motion and urged the Council to follow state law, as any deviation would subject the city to unwanted litigation.

A recent communication from the City Manager explains that the regulations are not being enforced and would need to be re-approved in the future. The Association will keep you abreast of any changes or developments on this front.
